2008 Summer Registration Information For Parents

We are looking forward to an excellent summer and have many fun and exciting activities planned for our members. The following information should help you understand summer registration and programming. During the Summer Program, Girls Incorporated serves girls ages 4 -18 at the Ascension Center.

1. In order to participate, each girl must be a member of Girls Incorporated of St. Louis. This annual fee is **\$25 per girl** each calendar year and if not already paid, must be paid at the time of registration. Registration will not be considered complete and forms and payments can not be accepted unless an **original Birth Certificate** is presented to verify the girl's age.
2. The summer program, which begins at 7 AM and ends at 5:30 PM, has a fee of at least \$225 and varies according to class choices. These fees, with any Optional Services, must be paid in full by **Friday, May 16, 2008 at close of business (6pm)**. Failure to pay by Friday, May 16th will result in the loss of your member(s) place in our Summer Program, **regardless of balance due.**

****ALL FEES ARE NON-REFUNDABLE AND NON-TRANSFERABLE****

3. If you need special consideration in the payment of fees, please ask for and submit the Fee Assistance Request Form. Additional documentation will be required. A **very limited** amount of funds are available for Scholarships and they will be awarded on a first-come, first-served basis.
4. The summer program will begin **Monday, June 9** and end on **Friday, August 1, 2008**. This is an eight-week program. The Center will be closed Friday, July 4th.
5. Breakfast and lunch will be offered by Girls Incorporated of St. Louis through the USDA Summer Food Program. Members may bring their own breakfast and/or lunch. **There will be no refrigeration or heating/cooking services provided for members who choose to bring their breakfast/lunch.**
6. Each fully paid summer program participant will receive one (1) Girls Inc. T-shirt and (1) badge for identification. Girls Inc. T-shirts **and** badges are **required** to be worn on field trips in order to participate in the outing. Additional shirts may be purchased for \$7 each. Replacement badges are \$7.00 each.
7. Girls Incorporated's rules and procedures apply during the summer program just as they do during the school year. (see Parent Handbook)

****LATE FEES** - A late fee, equal to \$1 a minute, payable at pick-up, will be charged each minute the member is at the Center past closing time. **During the summer months, June through August, the closing time is 5:30 PM.**

*****Members will not be allowed to return to the Center until this fee has been paid.*****
