In 2017, Girls Incorporated served close to 8,000 girls across 62 schools in the St. Louis region, and we could not have done it without generous donors and program partners like you!

We were honored to be visited by former President Bill Clinton, who viewed the Eureka! Program that meets all summer and every Saturday during the school year. Eureka! provides increased science, technology, engineering, and mathematics (STEM) education to underserved girls and young women in low income neighborhoods in St. Louis, enabling and empowering them to lead financially sound, productive lives and preparing them for the world of work. President Clinton met with program participants and viewed their various STEM projects.

Another upcoming STEM program about which we are very excited is the Imagine Science Program for girls ages three to eight. In addition, Girls Inc. of St. Louis recently signed an agreement to partner with the Urban League, and INROADS, Inc. to ensure that talented pre-collegiate underserved St. Louis high school scholars will have an opportunity to receive academic success with a focus on college and career-readiness.

This year we were thrilled to receive the Girls Inc. Growth grant for \$400,000! Girls Inc. of St. Louis continues to be one of the top affiliates in the nation, annually receiving accolades from our leaders at the national level.

As we pursue opportunities to expand our reach, we graciously accept the challenge and responsibility of educating the next generation of leaders. Thank you for helping us and our girls to become STRONG, SMART and BOLD.

## The Beat Goes On!

#### **Innovative Program Combines Music and Technology**

If you visit Girls Inc. after school or during the summer, you're likely to hear the sounds of music – dozens of first through seventh graders producing music or singing songs. In the last five years since Demetrius Beverly has been the music teacher, the agency's program has reached a high note. When he started the girls were learning the basics of music, how to count and how to identify notes. Now the music production program teaches girls how to create music digitally on the computer and then how to play it on keyboards. Last year, girls in the summer program got a chance to write and record their own song. "A lot of the kids don't have music at school so it's up to me to provide a platform where they can express themselves through music," says Beverly. "Plus, music shows them how to stand up straight and how to project, two skills they can use in the real world."

Beverly has also added a choir to the agency's music program. Girls learn how to identify different vocal parts and how to count. Now the choir is performing at locations such as The Muny, America's oldest and largest outdoor musical theatre. For the last two years, the Girls Inc. Choir has been the opening act for the theatre's summer Broadway series. They have performed excerpts from the movie "Trolls" and "Lion King." Beverly says some of the testimonies he gets from parents brings him joy. "Just last year I had a girl that never participated in anything but then joined the choir. After a choir performance, her mother came up to me and said 'my child really doesn't do anything. She's an introvert. But the past few weeks choir is all she can talk about."

Recently, Girls Inc. received a grant to build a new music facility so it will have ten stations that include a computer and a keyboard. Participants will be able to record music, score, mix, master and produce their own compositions. Thanks to this grant, the beat will definitely go on at Girls Inc.! *"What I like about music class is we get to practice a lot, because when you practice you get better and better."*

## Betty Sims "Wow" Scholarship Winner Wants to Pay it Forward

Deja Brown started attending Girls Inc. in St. Louis when she was six-years-old. Twelve years later, she graduated from Cardinal Ritter College Preparatory High School as valedictorian and winner of the 2017 Betty Sims "Wow" Scholarship.

"I met Betty Sims a few times personality before she passed away. She was a great person. I know a lot of people came together to put this scholarship in her name and I want to live up to that name. I know she did so much with her life, I want to pay it forward."

Deja is pursuing a degree in pharmacy because her desire is to help people through healthcare. She doesn't want to stop there though, and hopes to become a mentor doing bigger and better things for the community as a whole.

She started by giving back to her alma mater, Cardinal Ritter, where she volunteered as a dance coach over the summer. She also came back to Girls Inc. to help lead the younger students in the place that taught her to be herself and pursue her dreams.



Now a college freshman at University of Missouri Kansas City, Deja wants to use her education to honor the women who came before her.

It's something that you have to experience to know and understand how Girls Inc. has shaped my life. Ms. Jones and the leaders there have 100% changed my life for the better."

The annual luncheon, our largest fundraiser, recognizes outstanding Girls Inc. of St. Louis volunteers and strong, smart and bold girls. Schloarhips were awarded to outstanding high school seniors. A special performance of excerpts from "The Wiz" was given by Girls Inc. members and the choir. The Bringing Girls to the Center program is funded by the more than \$230,000 that was raised during the event.






